Withdrawals	You can make up to one withdrawal per month. Withdrawals exceeding this frequency will affect the interest accrued on your existing account balance.
Account Closure	<ul style="list-style-type: none"> <li>Should the Bank decide to close the E-Saver Account, the Bank will inform you of its decision 60 calendar days in advance of the E-Saver Account being closed and will provide, in writing, the reasons for closure.</li> <li>If the Bank has reasonable grounds to believe there may be financial crime risks and potential fraud risks, the Bank can at its sole discretion immediately close or block the E-Saver Account without providing any advance notice or reasons.</li> </ul>
